1. All continuous evaluation and model exams are conducted using a common time table.
2. The results are intimated to the students on time.
3. Remedial coaching is imparted to the needy students.
4. Weak students are given additional assistance through scholar support program.

6.3.4 Research and Development

1. Research committee was constituted in the institution
2. The activities for establishing a research centre in commerce is well supported by IQAC
3. Students are encouraged to do research oriented PG projects.

6.3.5 Library, ICT and physical infrastructure / instrumentation.

1. The library automation work is completed.

3. Proposal for setting up language lab with 35 computers in the Dept . of English was submitted.

1. All newly appointed faculty members and non teaching members are selected through the conventional selection process.
2. Opportunities for attending orientation and Refresher courses were provided to the faculty members.

All permanent faculty members and administrative staff are selected through processes of Kerala Public Service Commission. Adhoc Class IV employees are recruited from the State Employment Exchange. Guest Lecturers are chosen through interviews with properly constituted Interview board.

PTA provided financial assistance to almost all departments in the college for promoting academic and administrative activities.

PTA encourages meritorious students by giving cash awards. All class room stationary items like attendance registers, attendance slips , white chinks etc are provided from PTA. Civil and Electrical maintenance work which are to be carried out in an urgent manner is financially supported by PTA.

So, students of our college are given the liberty to express fearlessly the difficulties they face in the teaching learning process in the classrooms, on the campus and with teachers, if any. Such confidential feedbacks collected will be consolidated and steps are taken by the college council and staff council to redress the grievances and problems of the students. For this purpose, printed questionnaires are distributed to them. They have the liberty to analyse the teachers and suggest remedial measures to be taken. This appraisal forms which do not contain the names or serial numbers of the students give them the liberty to express free and fair opinions. This mechanism of obtaining the feedback from the students is done once in a year and based on this, improvements, remedial measures and other necessary actions are taken. Thus the teaching – learning process becomes a meaningful and cooperative enterprise.

BEST PRACTICE - 1

1. Title of the Practice

Group for Interdisciplinary exchange (GUIDE)

2. Goal

The goals of the programme are listed below

- i. To provide a platform for interdisciplinary interaction among students and teachers.
- ii. Providing basic knowledge and understanding in various disciplines in a view to generate interest in interdisciplinary practices.
- iii. To promote students and teachers to present their ideas in the form of simple interesting lectures.

3. The Context

Even when the college offers post graduate and undergraduate programmes in a wide cross section of disciplines, an academic interaction between various departments was not that frequent. With recent advances in different subjects, it became so evident that research is more or less turning to be interdisciplinary. Such an interdisciplinary approach will develop only if there is an interaction in the intellectual level between different disciplines.

4. The Practice

As part of the programme interdisciplinary lectures were organized twice in a month on Fridays in the noon time. Teachers and students from different departments voluntarily gave talks on interesting topics of their respective discipline. This was followed by active discussions. The meeting was regularly attended by a bunch of students and teachers. To organize this intellectual exercise, a committee under the chairmanship of the Principal was constituted.

5. Evidence of Success

As many as 20 lectures were organized and all of them were seriously attended by teachers and students. The interactions brought together the academic community of the college. The confidence level of students in presenting lectures increased well.

6. Problems Encountered and Resources Required

The major problem encountered in the implementation of the programme was the difficulty in finding out the time slots for conduct of the programme. Also, even though, initially it was planned to bring one or two resource persons external to the college, the idea was dropped primarily because of the difficulty in obtaining funds.

BEST PRACTICE - 2

1. Title of the Practice

Walk with scholar programme (WWS).

2. Goal

The goals of the programme are listed below.

- i. to arrange specialized mentoring programs for students in Under Graduate Programs in Arts, Science and Commerce and to provide guidance for their future.
- ii. To facilitate necessary orientation to students to set appropriate high, attainable and real ambitions of life and to show the ways and means to achieve them.
- iii. To help students to identify avenues for development, areas for higher studies and other opportunities in life.

3. The Context

It has been observed that the students in Arts, Science and Commerce Colleges do not get necessary orientation to prepare them for employment or guidance necessary to select areas for higher study. Because of this, even the meritorious students find it very difficult to choose an employment or a particular higher study. This serious issue is addressed and tried to be solved through the programme

4. The Practice

The scheme is open for all newly admitted undergraduate students with 60% marks in the qualifying examination. The programme introduces the idea of mentoring and builds on the concept of mentor as a 'Guide' and 'Friend'. For the purpose of mentoring, two categories of mentors were identified - 'Internal Mentor' and 'External Mentor'. The Internal mentor is a faculty member from the college. Each Internal Mentor will be in charge of 6 students. 30 students were selected for the programme and consequently 5 internal mentors too. External Mentors were identified from persons working in Industry, as well as from professions like Engineering, Medicine, Architecture, Law, Hospitality, Media, Business, Teaching, Administration, etc. Each 'External Mentor' was given charge of 5 students. Hence a total of 6 'External Mentors' were identified by the college.

Students selected under the Programme were paired to two mentors- An Internal Mentor and an External Mentor. 130 hours were identified (20 hours per internal mentors and 5 hours per external mentors)

The progress of the Scholar (student) was evaluated at regular intervals by the Internal and External Mentors and necessary corrective measures were taken to meet the desired objectives.

5. Evidence of Success

The participants who initially had difficulty in presentations mainly due to stage fear, emotional imbalance, etc., have overcome the same and were presenting well at the end of the programme.

6. Problems Encountered and Resources Required

The framing of the timetable for the programme amidst other academic activities was the biggest challenge.
